- Legal issues of ensuring energy security in Germany and the European Union;
- Nuclear processing technologies and problems of international legal regulation;
- Problematic aspects of legal groundwork for energy law order on the electric power market;
- Problems of formation of the international legal regime of offshore fixed platforms and floating drilling rigs for exploration and production of oil and gas resources on the continental shelf:
- Legal aspects of ensuring energy security and goals for development of smart systems for accounting of energy resources.
