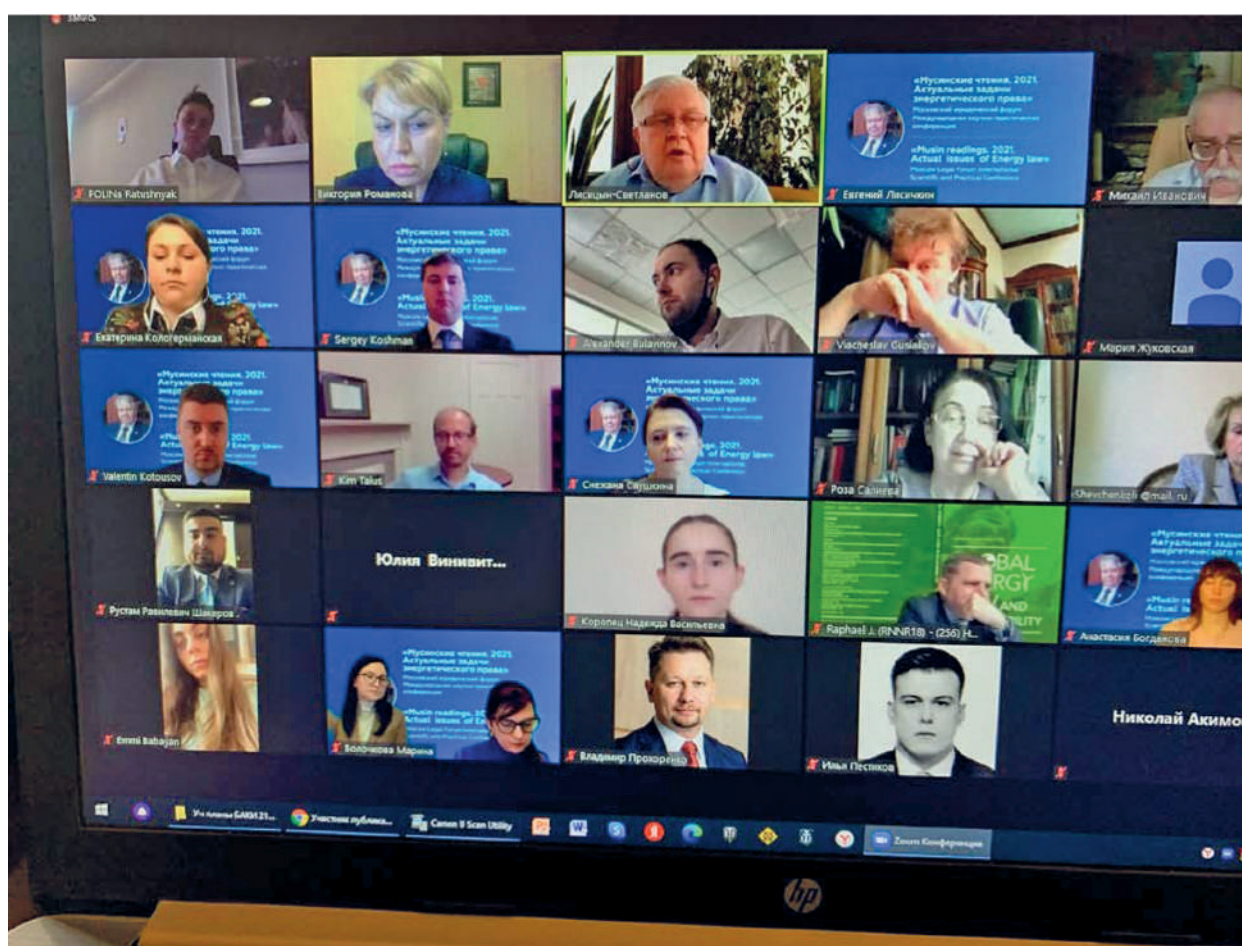
Maksim Nedzvetskiy, General Director of Gazprom VNIIGAZ, LLC, sent a welcome address to the event participants.
